The Ludwig Maximilian University and the Munich Center for Dispute Resolution are pleased to host the XXI All Munich Rounds from 13 – 15 March 2025.

The project “All Munich Rounds” – Goals and Experiences: Founded in 2005, the All Munich Rounds are the traditional Munich Pre-Moot for the oral pleadings of the Willem C. Vis International Commercial Arbitration Moot. Teams from various universities around the world will gather to practice their oral arguments for this year’s case in a friendly and competitive environment, modelled after the oral hearings in Vienna and Hong Kong.

Building on the success of the previous All Munich Rounds, we eagerly anticipate the 21st edition of the Munich Pre-Moot next spring. We hope that the encounter between teams from different universities will once again foster an intensive and efficient preparation for the competitions in Vienna and Hong Kong.

The target group of the All Munich Rounds consists of motivated teams from all over the world who share a passion and enthusiasm for this competition, thus creating the “moot spirit”.

The panels will feature experienced lawyers, professors, research assistants, coaches and former moot participants, providing valuable feedback and insights.

The practice rounds will be complemented by a series of **social events**, offering participants

the opportunity to get to know each other and enjoy the city of Munich.

The organisation of the Munich Pre-Moot is managed by the Munich Center for Dispute Resolution at Ludwig Maximilian University, under the leadership of Prof. Dr. Wolfgang Hau.

An **application form** is provided on page 3 of this letter. Please submit your application by **15 December 2024**. This will allow us to ensure smooth event planning while giving all interested teams sufficient time to coordinate their plans and secure funding. Since the number of applications typically exceeds the number of teams we can accommodate, we will only be able to provide final confirmation of participation to registered teams shortly after the registration deadline. We kindly ask for your understanding that, to maintain the quality of the All Munich Rounds, a **registration fee** of EUR 150 will be required from participating teams. Further details regarding payment will be provided upon confirmation of participation.
